Listed below are several criteria or activities which may be helpful in compiling this information. The list is obviously not inclusive, and it is intended only as a guideline for your use.

Contributions to professional forestry in one or more categories:

Widely recognized leadership role in the application of knowledge and service to forest resources.

Superior performance and service in the development and implementation of quality forestry programs at local, regional, or national levels.

Outstanding performance in teaching, research, development and extension, including but not limited to those associated with educational institutions.

Recognition of service and contributions through awards, honors, citations, offices commissions, etc.

Participation and service to various SAF activities at the local, division, or national levels.

Recognition of problems and needs in forestry and efforts directed toward meeting these challenges.

Conscientious concern and efforts in promoting professionalism among foresters, especially advising and assisting young professionals in achieving career goals.

Noteworthy contributions and support of forestry organizations or institutions through service, political activities, and/or philanthropic means.

Notable contributions to the area of conservation through rational concern over environmental issues and problems and participation in local, regional, or national ancillary organizations.

Beneficial contributions to the nominee's community as well as issues of character and integrity.
